Bluetongue

We held a client event on 19th March to discuss the current situation and to provide more information about the BTV-3 vaccines that have now been authorised for all of England and Wales. If you couldn't make it on the day, we have made the recording available on our website. Watch Now.

With the pleasant spring weather in mid-March, midge activity is expected to increase, and unfortunately that will mean an increase in bluetongue cases over the next months.

Please contact the practice if you would like to place an order for BTV-3 vaccine. If you have a small number of animals, we

are in the process of organising 'vaccine days' to split bottles between multiple clients, which will be more cost-effective for small herds/flocks. The planned 'vaccine day' is:

Avian Infleunza - Bird Flu

Currently – not much update on the Avian Influenza front. The mandatory housing requirement remains in place in the east of the country. The rest of England remains under close surveillance, with enhanced biosecurity measures required. Bird flu is mainly spread through contact with infected wild birds and their faeces.

FerAppease

We have recently started stocking a new product called 'FerAppease'. This is a maternal bovine appeasing substance, a pheromone, that is for use to help calm cattle. It can also be used on sheep, although the studies have not yet been published for this. The idea is for this to be used before and during any stressful event, to minimise the impact. There are no withdrawal periods as it is not a medicinal product.



Re-ewe-venate

We have a new product on our shelf – the latest addition to the Selekt range. The Reewe-venate drench, can be used for treatment of sick ewes around lambing showing signs of twin lamb or hypocalcaemia.

Animal Health + Welfare Policy

You can now apply for the animal health and welfare pathway grant to cover multiple species at the same time! This grant funds disease testing and "freestyle" vet time which you can use for any project which aims to improve animal health and welfare in your herd or flock.

- You do need a minimum number for animals to register (11+ cattle, 21+ sheep) and have SBI number
- Disease testing in cattle is BVD surveillance, in sheep it is worm drench testing
- Lump sum for the grant is paid on gov receipt of summary
- Includes VAN number! Saves on admin fee

If you have completed the grant, you can reapply for the grant 10 months after the last, as well as applying for "bolt-on" grant funding to further support vet time on farm.

Foot Crush

Did you know we have our own foot trimming crush? We can bring our foot crush to your holding for routine trimming as well as for problem cows that might need looking at. This can be added on to your TB test as an additional service. Contact the office now to get your cows booked in.










Bristol's Final Year Vet Students
